#### **HOUSING**

Homelessness; Priority needs; Vulnerable adults.

Johnson v Solihull MBC. [2015] UKSC 30. Supreme Court (SC). Lord Neuberger PSC; Lady Hale DPSC; Lord Hughes, J.S.C.; Lord Wilson J.S.C.; Lord Clarke, J.S.C.. May 13, 2015

The assessment of whether a homeless applicant was "vulnerable" for the purposes of the Housing Act 1996 s.189(1)(c) involved asking whether he would be more vulnerable than others in the same position. Any support that would be offered to him by family members while he was homeless had to be taken into account.

Appeals allowed in part

R. (on the application of Hemming (t/a Simply Pleasure Ltd)) v Westminster City Council. [2015] UKSC 25. Supreme Court (SC). Lord Neuberger PSC; Lord Mance, J.S.C.; Lord Toulson, J.S.C.; Lord Reed, J.S.C.; Lord Clarke, J.S.C.. April 29, 2015

The Supreme Court referred to the European Court of Justice questions as to whether the fee-charging practice of Westminster City Council in respect of licences for sex establishments was consistent with Directive 2006/123 art.13(2).

Regulation and Inspection of Social Care (Wales) Bill 2015.

A Bill to reform the regulatory regime for care and support services; provide for a regulatory framework that requires an approach to the regulation of care and support services focused on outcomes for service users; reform the inspection regime for local authority social services functions; provide for the reconstitution and renaming of the Care Council for Wales as Social Care Wales and the broadening of its remit; and reform the regulation of the social care workforce.

Commencement; Homelessness; Local housing authorities' powers and duties; Wales.

The Housing (Wales) Act 2014 (Commencement No.3 and Transitory, Transitional and Saving Provisions) Order 2015. SI 2015/1272 (W.88) (C.73)

This Order brings into force, on 27 April 2015, the Housing (Wales) Act 2014 Pt 2, with the exception of s.75(3) (intentionally homeless households with children) and the partial exception of s.78 (deciding to have regard to intentionality).

Judge ousts corrupt Muslim mayor. Times, April 24, 2015, 1,12,13. By Dominic Kennedy. Also Reported in Guardian, April 24, 2015, 4; Daily Telegraph, April 24, 2015, 1,4,5

Lutfur Rahman, mayor of the London Borough of Tower Hamlets, has been ousted by the High Court after it found he had rigged his election by using religious intimidation to compel voters to back him. He is the first person since the 19th century to be found guilty of unlawful religious influence. He is to be reported to the Solicitors Regulation Authority, and also faces bankruptcy with legal costs estimated at GBP 1 million.
