CASE LAW

ADMINISTRATION OF JUSTICE. Planning.

Access to justice; Court administration; Court offices; Issue of proceedings; Planning applications; Time limits; Weekends.

Croke v Secretary of State for Communities and Local Government. *[2016] EWHC 2484 (Admin).* Queen's Bench Division (QBD). Judge Alice Robinson. October 11, 2016

The principle in Kaur v S Russell & Sons Ltd [1973] Q.B. 336, [1973] C.L.Y. 1964 that a claim could be brought on the next working day if the time limit for making it expired on a non-working day did not apply where a litigant had been physically prevented from accessing the court office on the last day before expiry of the time limit. Litigants had to anticipate that a court might be busy, or that there might be security procedures preventing them from accessing the court office before it closed for the day.

Application refused

MENTAL HEALTH.

Admissions for treatment; Deprivation of liberty; Drugs; Eligibility; Mental illness; Persons lacking capacity; Standard authorisations.

BHCC v KD. 2016 WL 05484830. Court of Protection (CP). Judge Farquhar. August 30, 2016

In order to find that a person was ineligible to be deprived of their liberty by virtue of the Mental Capacity Act 2005 Sch.1A Pt 1 para.2 Case E, the court had to find that they were within the scope of the Mental Health Act 1983, that they were not subject to any treatment regime under that Act, and that all of the conditions in Sch.1A para.5(2) were met. It was not sufficient for only some of the Sch.1A para.5(2) conditions to be met.

Judgment accordingly

The Housing (Wales) Act 2014 (Commencement No. 7) Order 2016. SI 2016/1009

This is the seventh commencement order made by the Welsh Ministers under the Housing (Wales) Act 2014. It brings into force a number of provisions on 23 November 2016.

The Self-build and Custom Housebuilding Regulations 2016. SI 2016/950

The Self-build and Custom Housebuilding Act 2015 requires relevant authorities to keep a register of individuals and associations of individuals who are seeking to acquire serviced plots of land in the authority's area and, unless exempt, to grant sufficient development permissions to meet the demand for self-build and custom housebuilding. These Regulations make provision in relation to the definition of a serviced plot of land, registers kept under the Act and exemption from the duty.

Transparency in the Family Courts: Guidance by the President of the Family Division. Issued by Courts and Tribunals Judiciary. 18 October 2016

President of the Family Division, James Munby, has confirmed that the "Anonymisation and avoidance of the identification of children and the treatment of explicit descriptions of the sexual abuse of children in judgments intended for the public arena: judicial guidance" published by the Association of Lawyers for Children and Dr Julia Brophy has not been approved or issued as formal Guidance. Mr Munby is considering issuing formal guidance, and intends to consult on this.

Local Government Association briefing Homelessness Reduction Bill. Issued by Local Government Association. 10 October 2016

The issues relate to new duties the Bill would place on councils as well as the new mandatory code of practice that is planned alongside the Bill. Local authorities admit waste charges have increased fly-tipping. *Times, 20 October 2016, 7*. By Ben Webster.

Allison Ogden-Newton, chief executive of Keep Britain Tidy, has called on the Government to give local authorities some of the £1.1 billion a year collected in landfill tax, after its survey found that local authorities privately concede that the introduction of certain domestic waste charges and shorter opening hours at waste management sites have been a major cause of fly-tipping, which rose by 5.6% in 2015, at a cost of nearly £50 million to clear up.

Charities oppose Bill that threatens child protection laws. *Independent, 5 October 2016 (Online edition).* By Ben Kentish.

The Children and Social Work Bill 2016 will give local authorities significant new powers to opt out of child protection rules, according to a group of charities. Forty charities, including Liberty and the Howard League for Penal Reform, argue the Bill could result in councils ignoring child protection laws, arguing they have better, or cheaper, solutions. The Bill would give ministers the powers to exempt local councils from duties to children in social care.
