Consortium Annual Training Event 2017 Your Feedback

As reported in our last issue we have had really positive feedback from last year's event.

Our delegates, speakers and exhibitors alike spoke highly of the programme, the event itself and in particular the interest and enthusiasm from all the delegates.

The Management Board and Steering Group have looked at the feedback that delegates provided.

In particular it was great to hear from delegates that

- over 75% rated 'venue and administration' as excellent
- over 90% rated 'relevance and content' as good or excellent
- over 90% rated speakers as good or excellent

When asked what was most useful about the event delegates commented that

- a very successful day with a good mix of speakers/sessions
- well organised good attendance by exhibitors

On the less positive side we also had some comments about lack of printed slides being available and that tea and coffee could have been hotter. We have picked up these comments and will ensure these issues are dealt with for next year's event.

We also had a few comments about the fact that no workshops were on offer covering child and adult social care. The Management Board are committed to providing as wide ranging and interesting conference content as possible so that the event's appeal is as wide as possible. In a previous year we did offer a child care workshop in response to similar comments. However sadly only a very low number of delegates attended the workshop which was very disappointing for the speakers and those that did attend as the quality of the session was somewhat limited.

In response to this feedback, the Management Board would very much like to hear from Child Care and Adult Care legal staff across the NWLC membership as to how best we can serve your





needs generally into the future. Would you like us to arrange training from Barristers Chambers on a regular basis? Or are your training needs met elsewhere? Are there any gaps in otherwise available training that we could try to fill for you?

How your support matters - Graham Calder's story

Last October, I was travelling home from Preston after visiting my daughter, Grace, and her family for the weekend. I was still on the motorway when I got an awful phone call — my grandson Luca had suffered a nasty scald in an accident with boiling water, and the emergency services were on the way. I immediately turned the car around and headed back to be with them.

It was heartbreaking to hear what had happened. The only relief I felt was hearing how quickly Luca was in safe hands with the North West Air Ambulance paramedics, who were with him within minutes of the accident. Grace travelled with Luca in the helicopter to Alder Hey Children's Hospital, where the paramedics handed him over to the wonderful care of the hospital's nurses and doctors.

Thanks in part to the speedy arrival to Alder Hey and the care Luca received en route, he didn't sustain any serious injuries. He was in hospital for a few days, and is now making a fantastic recovery. From start to finish, the care and professionalism of everyone who was there for Luca was outstanding, and I'm so grateful to the air ambulance pilot and paramedics who helped him that day.

So, next year I'm going to be taking on one of the biggest physical challenges of my life in support of the North West Air Ambulance's fantastic service, by running the Great Manchester Run's Half Marathon. I want to give back to the charity and crew who were there for my 17-month old grandson when he needed them most.

Getting ready to run...

It wasn't until Luca was airlifted that I realised the North West Air Ambulance relied completely on donations. Knowing how crucial the service was to my grandson that day motivated me to do something – anything – to say thank you. I'd taken up running a few months before to improve my health, so when I saw that I could raise money for the charity by taking on the Great Manchester Run's Half Marathon, it made perfect sense to get involved.

I'd been a good athlete in my teens, but work and life eventually got in the way! Since taking up training for the Half Marathon, there's been a massive improvement in my fitness – I've actually lost 5st so far. I'm already comfortably running 10K, and as we edge closer to the big day, I'm ready to keep pushing past the milestones to reach the finish line.

As part of my training, I've been running every Monday with my local Park Run group. I'd really recommend group runs to people who want to take up the sport. The tips on the Great Run website have also been invaluable in making sure my training is on schedule.





For anyone who's thought about taking on a physical challenge for the charity, or who might be on the fence about taking the plunge, I say just go for it. The charity offers so much support once you've signed up, and joining Team NWAA means I've been given a lot of good advice and resources for fundraising ahead of the big day. I'd love for you to join me out there – it's just one way you can make a real difference to an amazing charity. It's literally a case of signing up here, pulling on your trainers and getting out there

Although it sounds a bit cliché, you honestly never know when you or a loved one will need the North West Air Ambulance Charity's service. Running a Half Marathon is my way to say thank you for all the charity has done for Luca. Wish me luck for 20th May – and I hope I'll see you at the starting line!

CASE REPORTS

FAMILY LAW. Civil evidence; Administration of justice.

Admissibility; Covert surveillance; Family proceedings; Guidelines; Judicial decision-making; Video recordings.

B (A Child), Re. [2017] EWCA Civ 1579. Court of Appeal (Civil Division) (CA (Civ Div)). Sir James Munby PFD; King LJ. October 18, 2017

The President of the Family Division acknowledged the need for publication of proper guidance as to how courts should approach the use of covert recordings in family proceedings. He prohibited the publication of a lower judgment in the instant case that purported to give such guidance, on the ground that it was not part of the function of a circuit judge sitting in the Family Court to unilaterally provide a "guidance judgment". He invited the Family Justice Council to consider the issue from a multi-disciplinary viewpoint.

Panayiotou v Waltham Forest LBC. [2017] EWCA Civ 1624. Court of Appeal (Civil Division) (CA (Civ Div)). Lewison LJ; Beatson LJ; Newey LJ. October 19, 2017

The court considered the meaning of term "significantly" as referred to in Hotak v Southwark LBC [2015] UKSC 30, [2016] A.C. 811 for the purpose of determining whether a person was "vulnerable" within the meaning of the Housing Act 1996 s.189(1)(c).

Judgment accordingly

Torbay Council v Torbay Quality Care Forum Ltd. [2017] EWCA Civ 1605. Court of Appeal (Civil Division) (CA (Civ Div)). Lord Burnett LCJ; Beatson LJ; King LJ. October 19, 2017

There was nothing in the applicable guidance which precluded a local authority from taking account of certain revenue streams (private fees, top-up payments and support from the NHS) when making the evaluative judgment of what it would expect to pay for residential care for the elderly.

Appeal allowed

The Regulation of Social Housing (Influence of Local Authorities) (England) Regulations 2017. Draft

The Regulations reduce the influence local authorities have over private registered providers of social housing. They restrict the percentage level of officers a local authority may nominate as board members of a private registered provider and removes a local authority's ability to hold voting rights as a member of a private registered provider.

Oxford to be first UK city to ban all polluting vehicles. *Times, 12 October 2017, 1,2.* By Ben Webster. Also Reported in Independent, 12 October 2017 (Online edition); Daily Telegraph, 12 October 2017, 11

Oxford City Council and Oxfordshire County Council have proposed that petrol and diesel vehicles be banned from the centre of Oxford from 2020 to create the UK's first zero-emission zone. The authorities are the first to produce comprehensive plans for improving air quality to address illegal levels of pollution. The plans contrast with London, where drivers of polluting cars will still be able to enter the city centre if they pay a fee.

Westminster Council seeks to launch voluntary mansion tax. *Sunday Times, 1 October 2017, 4.* By Nicholas Hellen.

Westminster Council has announced plans to launch the UK's first voluntary "mansion tax" for the owners of properties worth more than £10 million. It is seeking powers from the Government to collect a payment of £1,376 a year from the estimated 2,000 owners of £10 million properties within band H, doubling the £1,376 they already pay in council tax from April 2018, with the aim of raising an extra £2.75 million a year.
