New Blackpool base an uplifting force for lifesaving charity

The North West Air Ambulance Charity (NWAA) has moved to a brand-new base at Blackpool Airport, improving its capability to carry out lifesaving work. The base, which was funded in part by the generous donations of people across the North West, has given the crews a better environment for work, helping them to carry out lifesaving missions throughout the region with greater efficiency. It is one of two dedicated bases for the charity, with a second base at Barton Airport.

Features of the new base include a bespoke hangar for its emergency vehicles, with space for a helicopter and two rapid response vehicles, along with improved staff facilities. These include dedicated engineer and pilot rooms, as well as amenities such as new showers and a kitchen.

It is the first time that NWAA has had a permanent base in Blackpool and will serve as a major operational improvement for the crews, who previously worked out of modular units. The move to the new base has been made possible thanks to charitable donations from supporters and a collaboration with Blackpool Airport and Babcock International, which provides aviation services for the charity.

With no government funding, the charity relies entirely on donations from supporters and businesses across the North West. The service carries out lifesaving missions across the region, bringing vital pre-hospital care and providing hospital transfers to patients in their time of need. In 2019 alone, the crews attended 2,355 missions, evidence of the necessity of the service. Each year, NWAA must raise over £9.5 million to continue its lifesaving work.

CASES

HOUSING.

Breach; Burden of proof; Housing management; Multiple occupation; Reasonable excuse; Regulations; Regulatory offences; Standard of proof.

I R Management Ltd v Salford City Council. [2020] UKUT 81 (LC). Upper Tribunal (Lands Chamber) (UT (Lands)). Martin Rodger QC. March 19, 2020

Where a manager of a house in multiple occupation was charged with breaching the Management of Houses in Multiple Occupation (England) Regulations 2006 and thereby committing an offence under the Housing Act 2004 s.234(3), it bore the burden of establishing, on the balance of probabilities, the statutory defence of reasonable excuse provided for by s.234(4).

Appeal dismissed

PLANNING.

Buildings; Character and appearance; Conservation areas; Enforcement notices.

Planning: meaning of "building". P.L.B. 2020, 40(10), 77-78.

Notes Haringey LBC v Secretary of State for Housing, Communities and Local Government (Admin) on whether a terrace of houses in a conservation area, rather than each house, could be treated as a "building" within the Town and Country Planning Act 1990 s.55 for the purpose of determining whether work affected its external appearance and accordingly required consent. Advises caution in ensuring compliance with conservation area planning control.

Wellbeing of Future Generations Bill 2020 (HC Bill 124).

A Bill to make provision for requiring public bodies to act in pursuit of the United Kingdom's environmental, social, economic and cultural wellbeing by meeting wellbeing objectives, publishing future generations impact assessments, accounting for preventative spending, and through public services contracts; to





establish a Commissioner for Future Generations for the United Kingdom; to establish a Joint Parliamentary Committee on Future Generations; to require companies to consider the impact of their activities on the United Kingdom's wellbeing; and for connected purposes.

Code of Practice in relation to the performance and improvement of social services in Wales (Appointed Day) (Wales) Order 2020. SI 2020/328 (W. 75)

This Order appoints 1 April 2020 as the day on which the Code of Practice in relation to the performance and improvement of social services in Wales comes into force. The code is issued by the Welsh Ministers under the Social Services and Well-being (Wales) Act 2014 s.145.

Coronavirus; Emergency legislation; Landlord and tenant; Landlords' duties; Tenants' rights.

Greater protection for tenants and landlords affected by coronavirus in Wales. By Welsh Government. 22 March 2020

The Welsh Government has confirmed that measures being developed by the UK Government in response to the coronavirus pandemic, to suspend evictions from social or private rented accommodation, will apply to Welsh tenants. New protection will include: landlords being unable to start possession proceedings to evict tenants for at least a three month period during the crisis; and the three month mortgage payment holiday will be extended to Buy to Let mortgages to protect landlords.

Registration with CQC and changes to statements of purpose during COVID-19. By Care Quality Commission. 25 March 2020

The Care Quality Commission (CQC) has written to every registered care provider in England setting out how they are making it easier for them to tell the CQC important information about how they are responding, and potentially changing the way they work, to the coronavirus (COVID-19) outbreak. The CQC has been working with providers to adapt our regulatory approach and offer support to care providers.

Burials and cremation; Coronavirus; Funerals; Islam; Jewish law.

Burial rights of Muslims and Jews to be upheld. Daily Telegraph, 24 March 2020, 6.

Secretary of State for Health and Social Care Matt Hancock has assured Jewish and Muslim communities that their religious burial rights will be respected during the coronavirus outbreak, where emergency legislation has been amended to ensure that the beliefs of faiths were respected after concerns were raised over the possibility of forced cremations to relieve pressure on morgues and funeral services.

FAMILY LAW. Administration of justice; Health.

China; Coronavirus; Domestic violence and abuse; Her Majesty's Courts and Tribunals Service.

Domestic abuse fears raised due to self-isolation. *Times, 25 March 2020, 9*. Also Reported in Independent, 25 March 2020 (Online edition)

The head of the Courts and Tribunal Service, Susan Acland Hood, has raised concerns that self-isolation linked to Covid-19 will lead to an increase in domestic violence, where more women will be trapped indoors with an abuser. In parts of China the number of such cases rose to three times the norm after weeks of strict isolation.
