CASES

HOUSING. Charities; Local government; Human rights; European Union.

Charitable purposes; EU law; Housing allocation; Housing associations; Housing policy; Judaism; Local housing authorities' powers and duties; Proportionality; Public sector equality duty; Race discrimination; Religious discrimination.

R. (on the application of Z) v Hackney LBC. [2020] UKSC 40. Supreme Court (SC). Lord Reed PSC; Lord Kerr JSC; Lady Arden JSC; Lord Kitchin JSC; Lord Sales JSC. October 16, 2020

A charitable housing association's allocation policy, which effectively meant that it allocated housing only to applicants from the Orthodox Jewish community, was a legitimate and proportionate means of meeting the housing needs of members of that community. It was therefore not unlawfully discriminatory.

Appeal dismissed

MENTAL HEALTH. Local government.

Deprivation of liberty; Interim declarations; Mental capacity; Right to liberty and security; Standard authorisations.

DP v Hillingdon LBC. [2020] EWCOP 45. Court of Protection (CP). Hayden J. September 28, 2020

The Court of Protection issued guidance on the making of interim orders under the Mental Capacity Act 2005 s.48 where there was reason to believe that a protected person lacked capacity. It highlighted the difference between the court's jurisdiction in relation to s.48 orders and its function in relation to applications under s.21A, where its role was limited to reviewing standard authorisations for the deprivation of liberty that were already in force.

Permission to appeal granted, appeal allowed

CIVIL PROCEDURE. *Local government.*

Change of circumstances; Claim forms; Duty to the court; Gypsies; Interim injunctions; Local authorities' powers and duties; Prohibitory injunctions; Service by alternative permitted method; Travellers; Unknown persons; Unlicensed disposal of waste; Variation.

Enfield LBC v Persons Unknown. 2020 WL 05880520. Queen's Bench Division (Administrative Court) (QBD (Admin)). Nicklin J. October 02, 2020

The court declined to give a local authority retrospective permission to serve by alternative methods a claim form on which it had relied to obtain a three-year injunction to prevent persons unknown from setting up encampments or fly-tipping on public open spaces in its borough. There was a duty to refer an injunction to the court for reconsideration where parties were aware of a material change in circumstances and there was a real prospect of the court amending or discharging it. The Attorney General was invited to appoint an





Amicus to make submissions at the hearing of the local authority's application for a new interim injunction on the effect of Canada Goose UK Retail Ltd v Persons Unknown [2020] EWCA Civ 303, [2020] 1 W.L.R. 2802, [2020] 3 WLUK 70, [2020] 8 C.L. 42 on injunctions against persons unknown.

Application refused, Part 8 claim adjourned

Health Protection (Coronavirus Restrictions) (Functions of Local Authorities etc.) (Wales) (Amendment) Regulations 2020. SI 2020/1100 (W. 250)

These Regulations amend the Health Protection (Coronavirus Restrictions) (Functions of Local Authorities etc.) (Wales) Regulations 2020. The Regulations: expand the power conferred on local authorities to issue public place directions such that a direction may prohibit specified activities in a public place as well as restrict access to it; make minor and consequential amendments.

Health Protection (Coronavirus, Restrictions) (Self-Isolation) (England) Regulations 2020. SI 2020/1045

These Regulations make provision for the purpose of enabling public health measures to be taken to reduce the public health risks posed by the spread of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2), which causes the disease Covid-19, including self-isolation requirements in relation to persons who have tested positive for coronavirus and their contacts.

Health and Social Care Committee to publish report on Social Care: Funding and Workforce. By House of Commons Health and Social Care Committee. 19 October 2020

Following its inquiry into the reforms needed to the system of funding social care and the level of extra funding required from government in order to relieve pressures on the NHS and on people who need social care, the Health and Social Care Committee will publish its report on "Social Care: Funding and Workforce" at 00.01 on 22 October 2020.

Brexit; Global procurement; Public contracts; World Trade Organization.

Government secures access for British business to £1.3 trillion of global procurement contracts. By Department for International Trade. 7 October 2020

The Department for International Trade has announced that UK businesses will be able to continue bidding for public sector contracts around the world worth over £1.3 trillion a year, following engagement with World Trade Organization members. The Government Procurement Agreement (GPA) Committee confirmed the UK can join the GPA as an independent nation from 1 January 2021. Following the announcement, the Government published the guidance "Bidding for overseas procurement opportunities: what to expect from 1 January 2021" as part of its transition period collection.

Lifting children out of poverty and eliminating child hunger is a moral imperative. By Children's Commissioner. 13 October 2020

MPs from across the political divide will support a Ten Minute Rule Bill introduced by the Emma Lewell Buck on 13 October 2020. The School Breakfast Bill 2019-21 seeks to provide schools in disadvantaged areas with the support required to give a free, healthy school breakfast to children. The Bill though is unlikely to become law because it doesn't have the backing of the Government.

Housing experts have warned that illegal evictions have risen by 50% in some areas since the coronavirus pandemic began. Solicitor Giles Peaker has accused the Government of failing to confront the growing problem of rent arrears and asserts that courts should be given further discretion to decide whether a landlord can take possession of a home from a tenant who is in arrears.

Family sues for Grenfell law on disabled evacuation. Times, 5 October 2020, 18. By Robert Booth.

The family of Sakina Afrasehabi, a disabled woman who died trapped in Grenfell Tower, is suing the Government to force high rise owners to create evacuation plans for every disabled resident, a recommendation of the Grenfell inquiry. The Government's proposes that personal plans should only apply for people in buildings considered at immediate risk of fire. The legal challenge is the latest sign of frustration at the official response to the disaster which claimed 72 lives.
