## CASES

### **HOUSING. *Health; Immigration.***

**Coronavirus; Failed asylum seekers; Homelessness; Local authorities' powers and duties; Local government; Temporary accommodation.**

R. (on the application of Ncube) v Brighton and Hove City Council. [2021] EWHC 578 (Admin). Queen's Bench Division (Administrative Court) (QBD (Admin)). Freedman J. March 11, 2021

Local authorities could lawfully provide accommodation to street homeless persons with no recourse to public funds during the COVID-19 pandemic by virtue of their powers and duties under the Local Government Act 1972 s.138 and the National Health Service Act 2006 s.2B.

Declaration granted

### **MENTAL HEALTH. *Health.***

**Best interests; Brain damage; Care homes; Coronavirus; Persons lacking capacity; Risk; Vaccination.**

V, Re. [2021] EWCOP 14. Court of Protection (CP). Hayden J. February 10, 2021

It was lawful and in the best interests a care home resident in her 70s who suffered from a form of alcohol-related brain damage to be given the COVID-19 vaccination against the wishes of her daughter. Strongly held views by well-meaning and concerned family members should be taken into account but should not prevail over or be confused with the view's of the patient, as established by the entirety of the evidence.

### **PUBLIC PROCUREMENT. *Contracts; Health.***

**Broadcasts; Contract award notices; Contracts for goods; Contracts for services; Coronavirus; Locus standi; Public interest; Recordings; Remote hearings; Transparency.**

R, (on the application of Good Law Project Ltd) v Secretary of State for Health and Social Care. [2021] EWHC 346 (Admin). Queen's Bench Division (Administrative Court) (QBD (Admin)). Chamberlain J. February 18, 2021

When awarding contracts for goods and services during the COVID-19 pandemic, the Secretary of State for Health and Social Care had unlawfully failed to comply with his obligations under the Public Contracts Regulations 2015 reg.50 and with government policy which required him to publish certain tender and contract documents. The court examined the principles applying to standing to bring claims in the context of challenges to individual procurement decisions.

Application granted



### **SOCIAL WELFARE. *Human rights.***

**Children's homes; Freedom to manifest one's religious belief; Judaism; Learning disabled persons; Local authorities' powers and duties; Looked-after children; Proportionality; Religious discrimination; Religious education; Respite care; Right to respect for private and family life.**

A (Children) v Manchester City Council. [2021] EWHC 455 (Admin). Queen's Bench Division (Administrative Court) (QBD (Admin)). Judge Stephen Davies. March 01, 2021

A local authority had breached a child's ECHR art.9 right to manifest his religion by proposing to place him in residential respite accommodation where he would be unable to make/consume kosher food and participate in practices which were a crucial part of his faith as an orthodox Heredi Jew. The decision as to his placement was not proportionate where alternative accommodation had been found which was specifically for orthodox Jewish children, and which would enable him to practice his religion without restrictions.

Application granted in part

Domestic Abuse Bill 2019-21 (HC Bill 96).

A Bill to make provision in relation to domestic abuse; to make provision for and in connection with the establishment of a Domestic Abuse Commissioner; to prohibit cross-examination in person in family proceedings in certain circumstances; to make provision about certain violent or sexual offences, and offences involving other abusive behaviour, committed outside the UK; and for connected purposes.

**Annual reports; Homelessness; Housing supply; Local authorities' powers and duties.**

Housing and Homelessness (Local Accommodation Duty) Bill 2019-21 (HC Bill).

A Bill to place a duty on local authorities to ensure that persons for whom a homeless duty has been accepted are accommodated in the local area, including on discharge into private rented accommodation; to require local authorities to publish annual reports on steps relating to housing demand and supply taken or intended to be taken to meet that duty; and for connected purposes.

Equality Act 2010 (Commencement No. 15) (Wales) Order 2021. SI 2021/298 (W.75) (C.10)

This Order commences the Equality Act 2010 ss.1 and 3 insofar as they apply to a relevant authority as defined by s.2(6) of the Act.

**Access to information; Decisions; Documents; Executive arrangements; Meetings; Virtual meetings; Wales; Websites.**

Local Authorities (Executive Arrangements) (Decisions, Documents and Meetings) (Wales) (Amendment) Regulations 2021. SI 2021/357 (W.108)

These Regulations amend the Local Authorities (Executive Arrangements) (Decisions, Documents and Meetings) (Wales) Regulations 2001 to reflect the fact meetings of executives and their committees may be held partly or solely through remote means. They also require notices and agendas for executive meetings, reports connected with those meetings, written statements of executive decisions, reports considered when taking executive decisions and background papers to be published on an authority's website, although background papers are not required to be published on the website of an authority if it would not be reasonably practicable to do so.

**Case management; Housing Ombudsman Service; Investigations; Transparency.**

Housing Ombudsman starts publishing its investigation reports on individual cases. By Housing Ombudsman Service. 9 March 2021

In a major move towards increasing transparency, the Housing Ombudsman Service has begun publishing all individual decisions on cases investigated. Decisions will be published every two weeks, with the first cases highlighting issues including right to buy, moving home, repairs, and anti-social behaviour.

Further support for commercial and residential tenants. By Ministry of Housing, Communities and Local Government. 10 March 2021

The ban on commercial evictions has been extended to 30 June 2021 and the bailiff enforced eviction ban extended to 31 May 2021 to protect residential tenants, the Ministry of Housing, Communities and Local Government has announced.

Procurement Policy Note adoption for Wales. By Welsh Government. Procurement Policy Note (PPN) 11/20 17 March 2021

Procurement Policy Note (PPN) 11/20 from the UK Government sets out the options that may be considered by contracting authorities when procuring contracts for goods, services and works with a value below the applicable thresholds. The Welsh Government announces it is adopting the PPN and encourages the Welsh public sector to do likewise. It is also considering whether the scope of the PPN can be extended for Wales which would require publication of a Welsh procurement policy note.

Tribunal rules that LAs should not hide details of their borrowing and investments from the public. *Times*, 17 March 2021, 18. By Gareth Davies; Andrew Ellson.

Local authorities (LAs) should not hide details of their borrowing and investments from the public, a freedom of information tribunal has ruled in a decision that ordered Thurrock Council to disclose which local authorities it borrowed £800 million from and what "green energy" ventures the money financed.

**Coronavirus; Economic conditions; Statistics; Universal credit.**

Number of universal credit claimants doubles since start of pandemic to 6 million. *Independent*, 24 February 2021 (Online edition). By May Bulman.

Government figures have revealed that the number of people claiming universal credit in the UK has doubled from 3 million in March 2020 to 6 million in January 2021 since the start of the COVID-19 pandemic, prompting fresh concerns about plans to remove the £20 uplift to the benefit in April 2021. Claimant numbers have continued to increase month-on-month, rising by 2%, or around 90,000 people, in each of the past three months.
