They wish to maximise efficiencies and increase the effectiveness of the external legal support they require to supplement their in-house provision.

Sefton Metropolitan Borough Council, as lead authority for the NWLC has undertaken a procurement exercise for a Framework Agreement with external solicitors firms for the provision of legal advice and support in five lots, for the period May 2020 to March 2024.

There is also a Consortium Barristers Portal with registered Barristers Chambers available for the provision of advocacy and advice.

Building upon this successful collaboration, the Consortium authorities intend to increase inter-authority working and co-operation in the interests of increased efficiency and effectiveness.

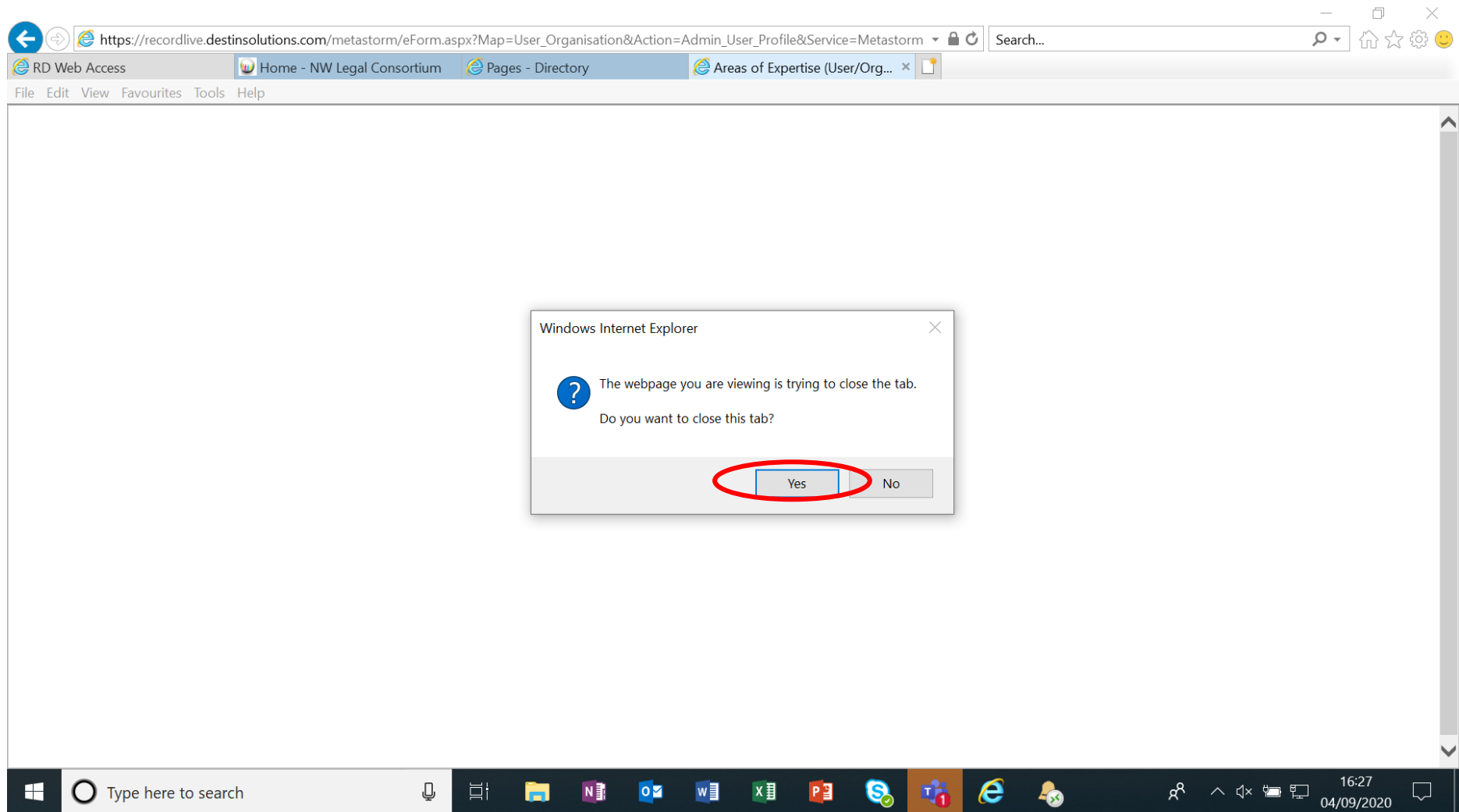
